Please note during mowing season at both St. Mary and St. Theresa Cemeteries, no benches, flower arrangements, statues, or any other objects are cemetery permitted on the ground that will interfere with mowing or weed-eating of the cemetery. Shepherds hooks are acceptable only if they are placed right next to the monument and the arrangements hanging from them don't interfere with mowing/ weed-eating. Small statues or any other objects placed on the base of a monument must be glued to the base so they don't end up on the ground. Please note that when flower arrangements get blown off a grave due to winds, we have no way of knowing which grave they came from.

Act of Contrition

Traditional form of the Act of Contrition, which was common throughout the 19th and the first half of the 20th century:

O my God, I am heartily sorry for having offended Thee, and I detest all my sins, because I dread the loss of Heaven and the pains of hell, but most of all because they offend Thee, my God, Who are all good and deserving of all my love. I firmly resolve with the help of Thy grace to confess my sins, to do penance, and to amend my life. Amen.

Modern form of the Act of Contrition:

My God, I am sorry for my sins with all my heart. In choosing to do wrong and failing to do good, I have sinned against You whom I should love above all things, I firmly intend, with Your help, to do penance, to sin no more, and to avoid whatever leads me to sin. Our Savior Jesus Christ, suffered and died for us. In His name, my God, have mercy. Amen.

An Explanation of the Act of Contrition

The USCCB advises a Perfect Act of Contrition for those who are unable to go to regular confession for any reason. A Perfect Act of Contrition requires a sincere desire for forgiveness and the firm intention to make a regular confession when it is safe to do so.

In the Act of Contrition, we acknowledge our sins, ask God for forgiveness, and express our desire to repent. Our sins are an offense against God, Who is perfect goodness and love. We regret our sins not just because left unconfessed and unrepented, they can prevent us from entering Heaven, but because we recognize that those sins are our rebellion against our Creator. He not only created us out of a perfect love; He sent His only begotten Son into the world to save us from our sins after we rebelled against Him.

Our sorrow for our sins, expressed in the first half of the Act of Contrition, is only the beginning, however. True contrition means more than just being sorry for the sins of the past; it means working hard to avoid those and other sins in the future. In the second half of the Act of Contrition, we express a desire to do just that, and to use the Sacrament of Reconciliation to help us do so. And we acknowledge that we cannot avoid sin on our own—we need God's grace to live as He wishes us to live.

An Examination of Conscience

Based on the Ten Commandments

I am the Lord your God: you shall not have strange Gods before me.

Have I treated people, events, or things as more important than God?

You shall not take the name of the Lord your God in vain.

Have my words, actively or passively, put down God, the Church, or people?

Remember to keep holy the Lord's Day.

Do I go to Mass every Sunday (or Saturday Vigil) and on Holy Days of Obligation (Jan. 1; the Ascension; Aug. 15; Nov. 1; Dec. 8; Dec. 25)? Do I avoid, when possible, work that impedes worship to God, joy for the Lord's Day, and proper relaxation of mind and body? Do I look for ways to spend time with family or in service on Sunday?

Honor your father and your mother.

Do I show my parents due respect? Do I seek to maintain good communication with my parents where possible? Do I criticize them for lacking skills I think they should have?

You shall not kill.

Have I harmed another through physical, verbal, or emotional means, including gossip or manipulation of any kind?

You shall not commit adultery.

Have I respected the physical and sexual dignity of others and of myself?

You shall not steal.

Have I taken or wasted time or resources that belonged to another?



Celebrate the Sacrament of Reconciliation

You shall not bear false witness against your neighbor.

Have I gossiped, told lies, or embellished stories at the expense of another?

You shall not covet your neighbor's spouse.

Have I honored my spouse with my full affection and exclusive love?

You shall not covet your neighbor's goods.

Am I content with my own means and needs, or do I compare myself to others unnecessarily?

Christ's Two Commandments

How well do we love God and others? Do we love as Christ calls us to? In the Gospel of Matthew, Christ gives us Two Commandments: "He said to him, 'You shall love the Lord, your God, with all your heart, with all your soul, and with all your mind. This is the greatest and the first commandment. The second is like it: You shall love your neighbor as yourself. The whole law and the prophets depend on these two commandments'"

(Mt 22:37-40).

Not sure what love is? St. Paul describes it for us in his Letter to the Corinthians. Is this how you love God and others? "Love is patient, love is kind. It is not jealous, [love] is not pompous, it is not inflated, it is not rude, it does not seek its own interests, it is not quick-tempered, it does not brood over injury, it does not rejoice over wrongdoing but rejoices with the truth. It bears all things, believes all things, hopes all things, endures all things. Love never fails"

(1 Cor 13:4-8).
